IMPORTANT: We have to be at ceremony site no later than 30 minutes prior to ceremony when shooting with multiple cameras. We have to properly adjust each camera for lighting conditions, put cordless mic on groom, officiant, shoot footage of ceremony site and some drone shots which requires 30 minutes of time. Therefore we recommend to be getting into dress 90 minutes before ceremony. If you wait till 30 minutes before getting in dress we will have no pre-ceremony shots of you in your dress.

If so make sure to allow some time for this. It should be done at least 90 minutes before ceremony, before things start getting too rushed and hectic. It is usually best to read it first quietly for the photographer, and then re-read it aloud a 2nd time for the videographer so that the noise from the photographer's shutter doesn't interfere with the audio. Another idea is to get audio of the groom reading his letter that he wrote and the bride reading her letter that she wrote, which we would shoot before you send the letters for the other to read. This takes a little more time, but can be better for the video.

Special Music Requests:

Current copyright laws require that music for the highlight video be royalty free unless you have a license for a particular song. Although we get our music from many websites the one most common is TheMusicBed.com. We are able to use most of the music on that site, so feel free to list any song you see that you would like for your video. We also have access to acquire a license from some of today's top artists like Ed Sheeran, Bruno Mars, Dan & Shay, and more at a cost of around \$60 per song. If you have a particular song in mind email Randy@CelebrationsofTampaBay.com and we can tell you if we are or are not able to use a particular song. When selecting music, keep in mind that it is good to use instrumental music as well, because we are adding in audio from the video (your vows, ministers words, toasts, etc). It is also good to allow us some flexibility because we are matching up mood and tempo of song with mood and tempo of video so sometimes there is no way to know ahead of time what is going to be best song for a particular spot on video. For music ideas it is good to look at our previous videos.
